## WHO WE ARE:

The Ontario Aggregate Resources Corporation (TOARC), through the Management of Abandoned Aggregate Properties (MAAP) program, rehabilitates former aggregate pits and quarries (deemed to be abandoned or legacy) in areas of Ontario that are designated under the Aggregate Resources Act and conducts and funds rehabilitation research.

MAAP's work is funded by the aggregate industry, paid for by producers, through a portion of the per tonne levy. The current portion for the MAAP program is ½ cent per tonne. In 2018, the portion of the levy for the MAAP program will be set to 0.006 cent and collected in 2019. Further years contribution to the MAAP program will be adjusted based on an inflation index.

## ABANDONED AGGREGATE PROPERTIES AND YOU:

The MAAP program has information on legacy aggregate sites throughout Ontario. MAAP employees visit the legacy sites prior to the construction season to examine the state of the site and discuss rehabilitation opportunities with the landowner.

In many cases the legacy aggregate site does not require rehabilitation. In those circumstances, MAAP would still appreciate the opportunity to examine the site and update its database with its new enduse.

## HOW ARE THE SITES CHOSEN?

To provide rehabilitation on an equitable basis the MAAP program targets counties and regions on a rotating basis each year. Within those counties or regions selected, projects are grouped to minimize travel and promote efficiency.

Sites in each county are chosen according to priority after a site visit by MAAP staff. For example a site with steep, un-vegetated slopes may be chosen over a more level site with less of a safety concern. The main objective of MAAP is to make abandoned pits and quarries safer, more productive, and more aesthetically pleasing. MAAP works directly with landowners to develop site plans that match future property goals.

## WHO COMPLETES THE PROJECTS?

Projects are designed by MAAP employees and the landowners. Each project is then publicly tendered to both local and Ontario-wide contractors. MAAP employees will ensure that projects are completed in a timely manner and as stated in the rehabilitation plan.

Rehabilitation of the abandoned pit or quarry may include grading and stabilizing slopes to make them safer, grading and seeding sites for agriculture or recreation, and creating and enhancing biodiversity in natural areas for wildlife habitat by planting native trees, shrubs, wildflowers, and grasses.

If your property qualifies for the MAAP program, you may sign a landowner acknowledgement form to confirm your interest in participating in the program. You may withdraw from the program at any time prior to project commencement.
